2024 WEST VIRGINIA STATE MOOSE BOWLING TOURNAMENT RULES:

1. ENTRANT/PARTICIPANT REQUIREMENTS: BOWLERS MUST BE A CURRENT MOOSE MEMBER IN GOOD STANDING. BOWLERS MUST HAVE A CURRENT USBC CARD PURCHASED IN WEST VIRGINIA. NO MORE THAN TWO BOWLERS WHO ARE MEMBERS OF OR HAVE APPLIED FOR MEMBERSHIP IN A PROFESSIONAL BOWLING ORGANIZATION CAN BE ON A 4-PERSON TEAM AND ONLY 1 ON A DOUBLES TEAM. YOU MUST HAVE A 21 GAME AVERAGE FROM AN ADULT LEAGUE AND MUST BE AT LEAST THE AGE OF 18 AT TIME OF ENTRY. THIS TOURNAMENT IS USBC CERTIFIED.

2 BOWLING OPPORTUNITIES: A BOWLER MAY COMPETE IN ALL SQUADS IN THE TEAM EVENT OF THIS TOURNAMENT. NOT MORE THAN TWO (2) BOWLERS ON THE SAME TEAM MAY PLACE MORE THAN ONCE IN THE PRIZE LIST FOR POSITION STANDINGS. A BOWLER'S FIRST TEAM AND FIRST DOUBLES/SINGLES EVENT SCORE WILL COUNT FOR ALL-EVENTS. A BOWLER MAY COMPETE IN ALL SQUADS IN THE DOUBLES AND SINGLES EVENTS. BOWLERS ARE ONLY ALLOWED TO CASH ONCE WITH SAME PARTNER. ALL BOWLERS ENTERING THE DOUBLES MUST ALSO BOWL IN THE SINGLES EVENTS. ALL BOWLERS ENTERED IN THE TEAM, DOUBLES AND SINGLES EVENTS MAY PARTICIPATE IN THE ALL-EVENTS BY PAYING THE SUM OF FIVE DOLLARS (\$5.00) PER ENTRANT AND/OR PAYING THE SUM OF TEN DOLLARS (\$10.00) FOR SCRATCH ALL EVENTS.

3. ENTERING AVERAGES: 1) ENTRANTS WILL USE THEIR 2022-2023 HIGHEST USBC LEAGUE AVERAGE OF 21 OR MORE GAMES. 2) IF NO AVERAGE FOR 2022-2023, USE HIGHEST 2021-2022 USBC LEAGUE AVERAGE OF 21 OR MORE GAMES. 3) IF NO AVERAGE FOR EITHER SEASON USE HIGHEST CURRENT SEASON 2023-2024 USBC AVERAGE AS OF APRIL 1, 2024 FOR 21 OR MORE GAMES. 4) ENTRANTS WITH NONE OF THE ABOVE AVERAGES MUST BOWL SCRATCH. **IT IS EACH BOWLER'S RESPONSIBILITY TO VERIFY THE ACCURACY OF HER OWN AVERAGE IN A HANDICAP TOURNAMENT, REGARDLESS OF SOURCE. FAILURE TO USE THE CORRECT AVERAGE WILL DISQUALIFY THE SCORE IF THE SUBMITTED AVERAGE IS LOWER THAN THE CORRECT AVERAGE, THEREBY RESULTING IN MORE HANDICAP. THIS INCLUDES ANY SPORT OR CHALLENGE AVERAGES ALSO. PRIZE WINNINGS WILL BE BASED ON THE SUBMITTED AVERAGE, IF IT IS HIGHER THAN THE CORRECT AVERAGE (RULE 31 9A, ITEM 3). WHEN PREVIOUS SEASON'S AVERAGE IS USED, AND AS OF APRIL 1, 2024, AN ENTRANT HAS A CURRENT AVERAGE FOR 21 OR MORE GAMES THAT IS 10 PINS OR MORE HIGHER, THEN THE PRIOR SEASON'S AVERAGE, THE CURRENT AVERAGE MUST BE USED.**

4. AVERAGE RERATING: THIS TOURNAMENT ENFORCES USBC RULE 319. THE AVERAGE OF A BOWLER WILL BE ADJUSTED UPWARD BEFORE PARTICIPATION IN ANY EVENT. IF THE ASSIGNED AVERAGE IS NOT ACCEPTED BY THE BOWLER, THE ENTRY FEES SHALL BE REFUNDED.

5. REPORTING OF PREVIOUS TOURNAMENT WINNINGS WILL APPLY (RULE 319D). THE AVERAGE ADJUSTMENT RULE WILL APPLY (RULE 31 9E). FAILURE TO COMPLY ON EITHER RULE IS CAUSE FOR FORFEITURE OF ENTRY FEES AND PRIZE WINNINGS.

6. HANDICAP PERCENTAGE USED: THE HANDICAP WILL BE BASED ON THE SCRATCH SCORE OF 220 PINS IN SINGLES, 440 PINS IN DOUBLES AND 880 IN TEAM. EIGHTY PERCENT. (80%) OF THE DIFFERENCE BETWEEN THAT FIGURE AND THE AVERAGE OF THE ENTRANT(S) WILL BE THE HANDICAP. **(80% of 220)**

7. PRIZES: AWARDS WILL BE GIVEN TO THE ACTUAL AND HANDICAP WINNERS IN THE TEAM, DOUBLES, SINGLES, AND ALL EVENTS. PRIZE FEES ARE RETURNED 100% IN CASH AND PRIZES. PRIZES PAID ARE BASED ON THE FOLLOWING ENTRY RATIOS: AT LEAST ONE IN EIGHT (1:8) IN TEAM, DOUBLES AND SINGLES, AND AT LEAST ONE IN FIFTEEN (1:15) IN ALL-EVENTS.

8. DRESS CODE: BOWLERS SHOULD LOOK PRESENTABLE. NO CUT OFFS, SLEEVELESS TOPS, SHORT SHORTS. ANY BOWLER APPEARING TO BOWL IN VIOLATION OF THIS DRESS CODE WILL NOT BE PERMITTED TO BOWL AND THERE WILL BE NO REFUND OF ANY ENTRY FEES. ANY BOWLER WHO VIOLATES THIS RULE DURING TOURNAMENT PLAY WILL BE DISQUALIFIED AND FORFEIT ALL ENTRY FEES AND PRIZES.

9. OTHER: TOURNAMENT MANAGEMENT WILL SCHEDULE LANE ASSIGNMENTS FOR EACH EVENT. IN THE MINOR EVENTS, DOUBLES WILL BE BOWLED FIRST, FOLLOWED BY SINGLES. THE TOURNAMENT DIRECTOR WILL ALLOW TEAMS TO BE PAIRED IF REQUESTED AND ENTRIES ARE SUBMITTED TOGETHER. TWO (2) TEAMS WILL BE ON EACH PAIR OF LANES, AND A MINIMUM OF TWO (2) SETS OF DOUBLES WILL BE ON EACH PAIR OF LANES. LANES WILL NOT BE SKIPPED BETWEEN TOURNAMENT BOWLERS. ALL DECISIONS OF THE TOURNAMENT MANAGER ARE FINAL UNLESS AN APPEAL IS MADE IN ACCORDANCE WITH USBC RULE 329.

10. TOURNAMENT IS SUBJECT TO CHANGE AND WILL FOLLOW ALL LOCAL, COUNTY, STATE AND NATIONAL GUIDELINES AS NECESSARY. TOURNAMENT OFFICIALS SHALL BE LIABLE ONLY TO THE EXTENT OF RETURNING ENTRY FEES, IF AND WHEN THE ENTRANTS SHALL BE PREVENTED FROM BOWLING ANY EVENT IN THE TOURNAMENT THROUGH DELAY, UNEXPECTED YET NECESSARY CHANGES IN SCHEDULE, OR PREMATURE TERMINATION OF THE TOURNAMENT.

11. CENTER MANAGEMENT/OWNER RESERVES ALL RIGHTS TO STOP ANY ACTIONS THEY DEEM EXCESSIVE/DANGEROUS, INCLUDING, BUT NOT LIMITED TO, KICKING OF BALL RETURNS, EXCESSIVE LANGUAGE, LOFTING OF BOWLING BALLS, OR ANY OTHER ACTION THAT MAY DAMAGE THE CENTER'S EQUIPMENT OR LANES. THEY ALSO HAVE THE RIGHT TO ASK A BOWLER TO LEAVE THE CENTER IF THE ACTIONS ARE NOT STOPPED.
